Enter jail 6:30-6:45, POD entry at 7:00, Lock Cars, Park in Handicap. At 9:00: Male Volunteers Escort Females to their car.

Currently have 5 Volunteers.

78 Female Inmates attended meetings.

Key Leader Jim Z: Need more Male Volunteers with 10 yrs. sobriety.

Currently have 8 Volunteers. One volunteer applying.

Female: 2 PODS Wednesdays 5-7PM. 5:15 to 6PM and 6:15-7PM due to Head Count At 6PM (If 2 Volunteers: Meetings Same Time 5-6PM).

Male: 2 PODS Mondays and 1 POD Wednesday: all at 7-8PM.

Be at jail: Females 4:45 and Males: 6:45. Park in front of jail, lock cars.

Key Leader Lisa C: No volunteers needed at this time.

Currently have 12 Volunteers.

58 Female Inmates attended meetings.

Key Leader Donald S: No volunteers needed at this time.

Currently have 9 Volunteers.

99 Male Inmates attended meetings.

FEDERAL CORRECTIONAL INSTITUTION COLEMAN: AA meetings deemed unworthy of providing a weekly escort to and from the chapel. Jim Zeveney is appealing the decision.
